Who runs IPUG?

The agenda for the group, and the way in which it is constituted, is ultimately a question for the membership. However, the day-to-day operation of the group is managed by the voluntary efforts of the Executive Committee, plus some part-time paid support from our IPUG Co-ordinators. At this time, the executive comprises a Chairman, Treasurer and eight other members. Who can join IPUG and how many members are there?

Currently IPUG has approximately 80 members, with most of the major banks and investment houses with offices in the City of London represented, although member firms can be located anywhere globally. To be eligible for membership you should be a financial institution, (bank, insurance company, securities house, securities brokerage, fund manager, building society or similar), be of any size and use market data services. Suppliers of market data services, whether they are data vendors, technology solution providers or consultancy firms are not eligible for membership.
